Leaving & Returning Times: We will leave for camp on Sunday, June 11th at 1pm (after am services). All campers need to eat and be back at the church by 12:30pm to load up. We will return home on Friday, June 16th around 2:30pm.

For Other Camp Visitors: All camp visitors must check in at the main camp office upon your arrival. In addition, if you plan to eat at the camp, you must purchase the \$15 per meal/person meal tickets from the camp office. Also, there are area motels that you can stay at. Call and reserve early, they book up fast.

RULES!

Youth Camp can be a fun and life altering experience for both teens and adults alike if we stick to these guidelines:

PLEASE NOTE – THESE ARE NOT OPTIONAL!

1. Everyone is always to dress modestly. No short shorts, skirts, or vulgar attire of any kind. Please dress nicely to the evening services. It does not have to be dress clothes, just clean, modest clothing.
2. No one will be allowed to skip scheduled classes, services, or leave the campgrounds without permission.
3. No drugs, alcohol, tobacco products, or vapes will be allowed. In addition, no fireworks, paintball guns, weapons of any kind, etc. will be allowed. (security will be designated and/or overseen by Minnetonka Christian Camp)
4. Disrespecting any leaders from VBC or another church will get you sent home! All counselors must be treated with respect and you in turn will be treated the same way.
5. No radios, electronic games, headphones, etc. will be allowed while at camp. All cellphones will be taken up the first day. Calls can and will be made only on an **EMERGENCY BASIS**. Please understand that camp is an intentional and designated time away from distractions. This type of focus causes them to be more involved in the games, fellowship, and most importantly, more focused on God's Word!
6. Please ensure that your teen is healthy and feeling well. We ask that you check for any signs of health-related illness such as: fever, shortness of breath, dry cough, runny nose, sore throat, rashes of any kind, or open wounds. Please remember that will be staying in a dorm that is tight quarters and we would never want to expose others purposefully or carelessly to anything that is contagious. **It is imperative that we all do our part in being diligent in this area.**

What to Bring:

1. Good attitude and open heart and mind
2. Your Bible (not phone), pen, and notebook
3. Clothes:
 - Remember we will have water games/swimming each day and also need good clean clothes for chapel time each night
 - Please don't bring your "best" shoes/clothes as they may get ruined during times of play/fellowship
4. Personal items: (only water and toilet paper are supplied)
 - Bedroll (Pillow, sleeping bag, twin size sheets, etc.)
 - Toothbrush, toothpaste, soap, shampoo, towels, etc.
 - Sunblock, bug spray, etc.
5. Proper swim attire (modest), towels, and life jacket for ages 13 and under (swim test will be administered for ages 14 and up)
6. Laundry bag for dirty clothes (a plastic trash bag also works well for wet clothes/shoes)
7. Prescriptions-please put ALL meds in a bag with directions to be held and administered by camp nurse (at no time may any medications be self-administered or kept in the dorms) All meds will be given to camp nurse upon arrival

Luggage Limit – 1 Suitcase/Bin + 1 Bedding Bag + 1 Smaller Bag (if needed). Please make sure bags are marked with their names.

Please talk to your teen about being responsible enough to keep up with their clothing and belongings.

You may send a card, letter, or package to your teen. They love to get mail! They will get their name called out at chapel in front of everyone. The camp's mailing address is listed on the front page of this packet. Remember that it will probably take at least 2 to 3 days to get to the camp so plan your mailing dates accordingly.
